Meals on Wheels greatly improves the quality of life for older adults by providing and delivering a hot, nutritious noontime meal to homebound people in our area. In 2015 Meals on Wheels served 85,531 meals to 585 seniors, eligible under Title III.

Retired and Senior Volunteer Program (RSVP) recruits and places senior volunteers with nonprofit and public sector organizations to provide community service. In 2015 621 volunteers provided 110,448 hours of community service.

4c (Code:) (Expenses \$ **99,513** including grants of \$ **3,041**) (Revenue \$)

Senior Solutions program is a comprehensive information and problem resolution service for older adults and their families in the service area. The program includes handyman services, food pantry, and medical equipment lending. Outreach locates and identifies isolated elderly citizens in need of assistance and refers them to appropriate services. In 2015 Senior Solutions served 5,791 clients.
